NEW MINES.

The Peabody Coal Company has put in operation mine No. 8, at Kincaid, Christian County. This mine is a duplicate of No. 7, and is modern in every respect. The coal is undercut with electric chain machines, hauled to bottom by electric motors, and the mine is equipped with electric hoist. Power is furnished from a central power station and the hoist is driven by a 675 H. P., 550 volt direct current motor connected to drum shaft by a flange coupling. The hoist is of a double conical type constructed of cast steel. An auxiliary motor is used to drive the hoist when the mine is not in active operation. The power used to operate mining machines and haulage motors is supplied by two 300 K.W. 275 volt motor generator sets. Meters are used to record the amount of power consumed by the hoist and by each machine. All surface buildings, excepting tipple, are constructed of brick and well ventilated. The cages are of the Olson self-dumping type and automatic cagers are used.

IMPROVEMENTS.

The Bunsen Coal Company has installed at No. 3 mine a Jeffrey Centrifugal booster-fan 4 feet by 26 inches, driven by a 35 H. P., 250 volt motor. at a speed of 650 revolutions per minute. At the Vermilion mine a Sullivan long wall machine and two 13-ton General Electric haulage motors have been installed and the tipples at Nos. 2 and 4 mines repaired.

FATAL ACCIDENTS.

July 1, 1913, George Krusua, loader, aged 33 years, married, was killed in Bunsen Coal Company's Vermilion mine, Georgetown, Vermilion County, by being struck by timber, causing rupture of large blood vessel. He leaves a widow and three children.

July 2, 1913, Lawrence Harrison, laborer, aged 35 years, single, was killed in Peabody Coal Company's mine No. 7, Kincaid, Christian County,
