## NEW MINES.

A new drift mine is being developed about half way between Edgemont and Caseyville by Aloys Gundlach. This mine will tap a 1,400 acre tract of coal and promises to be one of the greatest coal producers in the State.

Mr. Gundlach's intention is to have the screening and sizing plant at East St. Louis; the right-of-way has been purchased for the purpose of transporting the coal from the mine to the East St. Louis plant. He has contracted for the Keokuk power and is installing electric mining machines, with a view of developing the mine as rapidly as possible.

## FIRE AT MINE.

The engine and boiler-house of the Southern Coal, Coke & Mining Company's No. 6 mine was completely destroyed by fire May 30, 1914.

## IMPROVEMENTS.

The following improvements were made at the Southern Coal, Coke & Mining Company's No. 8 mine: Two 60-inch by 20 feet tubular O'Brien boilers, one 150 K. W. 250 volt Thompson Ryne generator, two Jeffrey mining machines, and one 7-ton Whitcomb gasoline motor were installed; a car haulage was put in to elevate and transfer the empty cars around the shaft bottom, and the fanhouse was lined with fire-proof material; a large electrical illuminated, safety first sign was put in at the shaft bottom; this is a great step toward the safety first movement, upon which the management deserves to be highly commended.

The Suburban Coal & Mining Company installed a 60-inch by 22 feet O'Brien boiler.

The Egyptian Coal & Mining Company installed the following machinery, at the Meek mine: One 100 K. W. multiple electric Goodman generator, driven by a 187 horse-power Ridgway engine; two 66-inch by 18 feet, 56 4-inch flues, Illinois boilers, and a 100-ton Howe track scale.

Oakdale Mining Company re-timbered the air shaft from top to bottom. The Pittsburg Mining Company's hoisting shaft was re-timbered from top to bottom.

The White Coal Company installed a pair of 16x32 first motion Litchfield hoisting engines and an endless rope haulage.

The Eldnar Coal Company installed a 20x30 Norwalk air compressor.

The New National Coal Company, the Vulcan Coal Company, and the Lattman mine, were given switches by the Southern Traction Company.

## FATAL ACCIDENTS.

July 25, 1913, Peter Laquet, miner, aged 68 years, married, was killed by falling clod at the face of his room, in the Fairbanks mine, Lenzburg, operated by the Kolb Coal Company. He leaves a widow and 12 children.
